With reference to your application dated 29/6/2012 and subsequent correspondence with the school/inspection in this regard,
Sir/Madam,

With reference to your online application dated 30/06/2012 on the subject cited above, I am directed to convey the sanction for **Composite Provisional Affiliation for Secondary School Examination and Senior School Certificate Examination** of the Board for a period of **three years w.e.f. 01.04.2013 to 31.03.2016**. The following subjects have been sanctioned to be introduced at Senior Secondary classes :-

(a) **Languages:-**

ENGLISH CORE, ENGLISH ELECTIVE, HINDI CORE, HINDI ELECTIVE.

(b) **Elective Subjects:**

PHYSICS, CHEMISTRY, BIOLOGY, MATHEMATICS, ACCOUNTANCY, BUSINESS STUDIES, ECONOMICS, PHYSICAL EDUCATION, COMPUTER SCIENCE, INFORMATICS PRACTICES.

The above sanction is subject to fulfillment of following conditions:-

1. "School will follow the syllabus on the basis of curriculum prescribed by NCERT for the middle classes".

2. The school will implement Continuous and Comprehensive Evaluation (CCE) as per the schemes of the Board

2. The school will implement Continuous and Comprehensive Evaluation (CCE) as per the schemes of the Board upto Classes X.
3. As per the newly implemented CCE scheme vide Circular No. **39/20-09-2009 dated 20.09.2009**, the students of class X will appear in the Summative Assessment-II (SA-II) conducted at the school level only. However, those students of class X, who opt to move out of CBSE system in Class XI to any other Board, will exercise the option to appear in the SA-II conducted at the Board level. Both the students will get the same certificate issued by the Board at the end of class X.
4. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State Govt./UT.
5. The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Secondary School Examination and Senior School Certificate Examination and changes made therein from time to time."
6. It will provide facilities for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
7. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
8. **It is case of switch over from State Board; the school is required to withdraw its affiliation from such Board as dual affiliation is not permissible. Also State Board classes IX and XI will not be continued w.e.f. 2013. However, for the Class X and XII Examination to be held in the year 2013 & 2014, the school will sponsor its students for State Board only.**

The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre-Primary to Class XII :-

(d)	School running on bigger campus of more than 02 acres, the number of students shall be restricted as per the actual facilities in the school which shall be proportionate to the optimum number mentioned at (a), (b) and (c) above.			

10. The School will not sponsor candidates for Board's examination of any other School/Branch, which is not affiliated.
11. **The school shall sponsor regularly its bonafide and eligible students in Board's class X and XII Examination from the year mentioned above without break or inform with reasons thereof in writing well in time about the non-sponsoring of the candidates. Failure to do so will lead to *suo moto* withdrawal of the affiliation of the school for secondary Examination granted by the Board.**
12. **The school shall appoint qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board.**
13. **Service conditions, pay and allowances and other benefits to the employees of the school shall be at least at par with that of corresponding categories of employees working in Government Schools of the State in which the school is located. An undertaking to this effect be sent to C.B.S.E.**
14. Service agreement be executed with the staff as per norms generally accepted by the State Government concerned.
15. The school will help the Board in the smooth conduct of the examination by providing the necessary accommodations i.e. Rooms, Halls, etc. available in the school premises and furniture at its disposal for holding its examinations free of charges if required.
16. The school will spare sufficient teachers, for invigilation purpose at the examinations of the Board, as may be required
17. The school will spare its teachers for evaluation of answer-books for the Board's examinations. if required.

17. The school will spare its teachers for evaluation of answer books for the Board's examinations, if required.
18. The school will provide Laboratories, Library and other facilities as per norms of the Board.
 19. The school will abide itself by the conditions of affiliation already prescribed by the State Government concerned.
 20. **The school should have at least one adequately equipped computer lab with a minimum of 10 computers or computer student ratio of 1:20 and proper software alongwith facility of Broad Band Connectivity with the feature of 'internet always on' from any service provider.**
 21. **The school shall promote inclusion of student with disabilities/special needs in the normal school as per provisions of the 'persons with disabilities act -1995'.**
 22. The school and its records shall be opened for inspection by an officer/official of the Board or an authorized representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.
 23. The rate of tuition fee and other fees charged should be commensurate with the facilities provided.
 24. The admission to the school shall be opened to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.
 25. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
 26. The school will strictly adhere with all rules regarding safety of students including Fire fighting, Drinking water, Sanitation, Transportation, etc.
 27. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared in the name of school, as per rules. A copy each of the Statements of Accounts should be sent to the Board every year.
 28. The affiliation Code Number allotted to your school is **1730579**. This may please be noted and quoted for any correspondence with the Board.
 29. The school will create Reserve Fund as per the requirement of the Affiliation Bye Laws.
 30. The school will apply for further Extension of Provisional Affiliation 'on online' through www.cbseaff.nic.in with the prescribed fee of **Rs. 25,000/-** and other essential documents before 30th June of the preceding year before the expiry of the date of provisional affiliation.
 31. The school will open CBSE pattern classes IX and XI **w.e.f. 1.4.2013**. Accordingly, 1st Batch of class X and XII of the school will be appeared at the Board's Examination to be held in the year **2015**.
 32. School will provide physical facilities as per norms of the Board. The facilities reported at the time of last inspection are as given under:-

 33. Other conditions are as per Annexure 'A' enclosed.
 34. Special conditions to be complied within three months:-

- i) It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE schools.
- ii) Every school should organize at least one week training programme for teachers every year in association with any teacher training institute recognized by the State or Central Government or by any agency identified by the Board.
- iii) Every institute will provide adequate facilities for potable drinking water and clean healthy and hygienic toilets with washing facilities for boys and girls separately in proportion to the number of students.
- iv) Trained and qualified PGTs should be appointed for the subjects in which the upgradation to +2 stage has been accorded before commencement of Senior Secondary Level Classes.
- v) The school is required to use the name of school strictly as given in the NOC.
- vi) The School Managing Committee (SMC) is required to be reconstituted as per provision of Affiliation Bye-Laws of the Board by including 02 Board's nominee in it and a copy of the same be furnished.
- vii) The school is required to develop the playground of the school and maintain its boundary wall for the safety of the students.
- viii) More books are required should be purchased for library.
- ix) The school is required to submit a copy showing details of class rooms and Laboratories i.e. Physics, Chemistry, Biology, Computer Science Lab and Mathematics Lab etc.
- x) Enrolment of student in some sections is less than 20 and therefore school is required to improve enrolment of students.
